ORDER FOR SERVICE OF PROCESS PURSUANT TO FED.R.CIV.P 4(f)(3)

Upon consideration of Plaintiff Deckers Outdoor Corporation’s (“Plaintiff”) Motion for Service of Process by Email, Electronic Publication and Publication pursuant to Fed.R.Civ.P 4(f)(3), IT IS HEREBY ORDERED

Plaintiff may complete service of process to Defendants by (1) sending a copy of the Amended Complaint via electronic mail at the e-mail addresses identified in Schedule A to Deckers’ First Amended Complaint; (2) electronic publication of the Amended Complaint on a website at the Defendant Domain Names which have been transferred to Deckers’ control; and (3) publication of sections 1-3 of this Order in *China Industry & Commerce News* or a comparable Chinese based publication in English or in mandarin language. If, despite its diligent efforts, Deckers is unable to secure a suitable means for publication in China within seven days of the date of this Order, Deckers may publish sections 1-3 of this Order in *The Washington Times* instead of the *China Industry & Commerce News*. An affidavit shall be filed on Plaintiff’s behalf describing the steps that have been taken to comply with this Order.


